ON 06-03-2013, I, LT. LESLIE, RESPONDED TO MEMORIAL STADIUM TO MEET WITH GARY WADE (EMPLOYEE) IN REFERENCE TO DAMAGE TO HOWARD'S ROCK. UPON ARRIVAL, I SPOKE WITH JEFFREY KALLIN (EMPLOYEE) AND WILLIAM LEWIS (EMPLOYEE), WHO ADVISED THAT THEY FOUND THE DAMAGE. I OBSERVED THAT THE PLEXIGLASS COVER WAS MISSING FROM HOWARD'S ROCK, AND I OBSERVED THAT A LARGE PIECE OF THE ROCK WAS MISSING. I FOUND THE PLASTIC COVER SITTING ON THE GROUND NEAR THE GATE. KALLIN AND LEWIS ADVISED THAT THEY DID NOT TOUCH THE COVER. KALLIN AND LEWIS ADVISED THAT THEY DID TOUCH THE PEDESTAL, AND THEY ALSO ADVISED THAT THEY PICKED UP SEVERAL PIECES OF THE ROCK AND PART OF THE LOCK FROM THE CASE.
